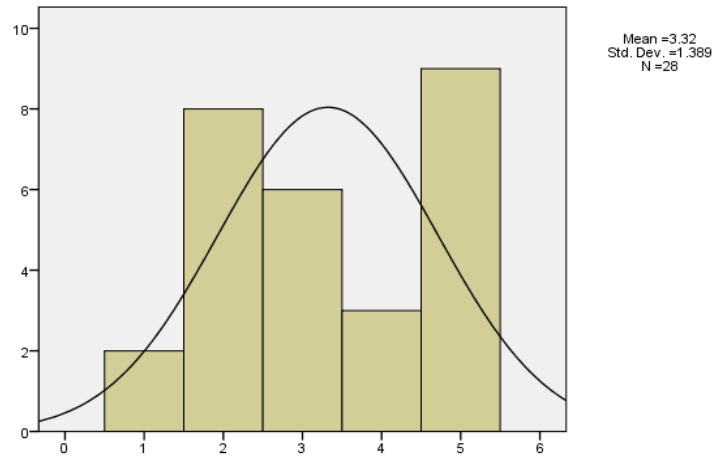

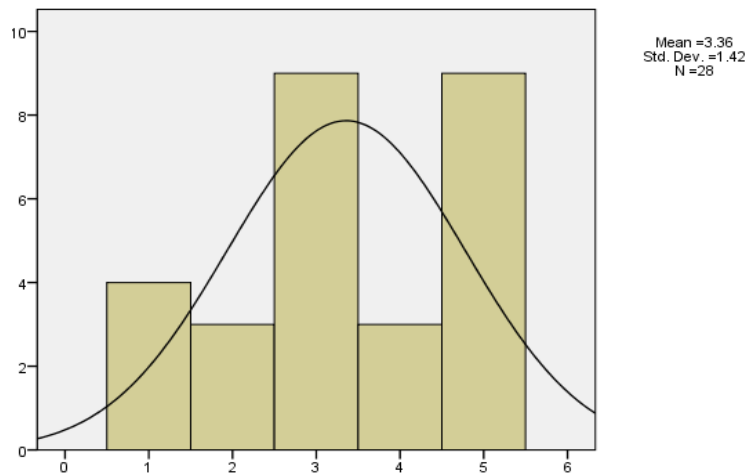

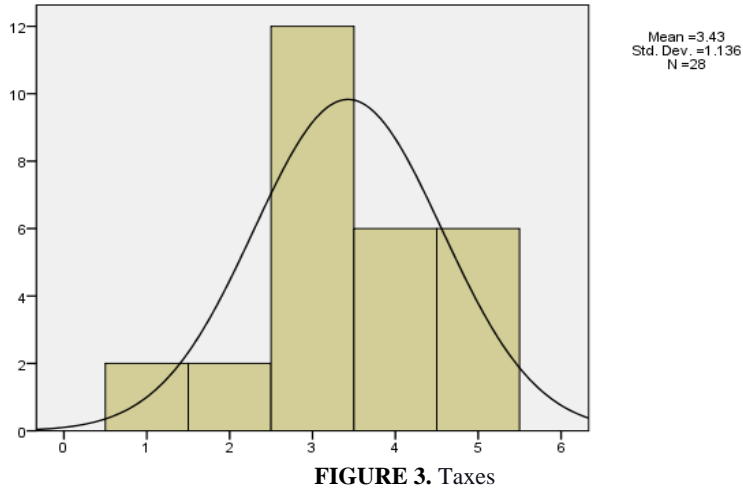

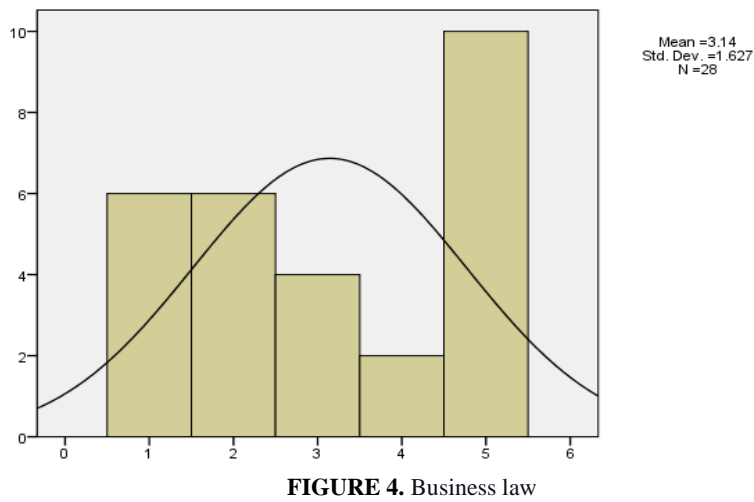

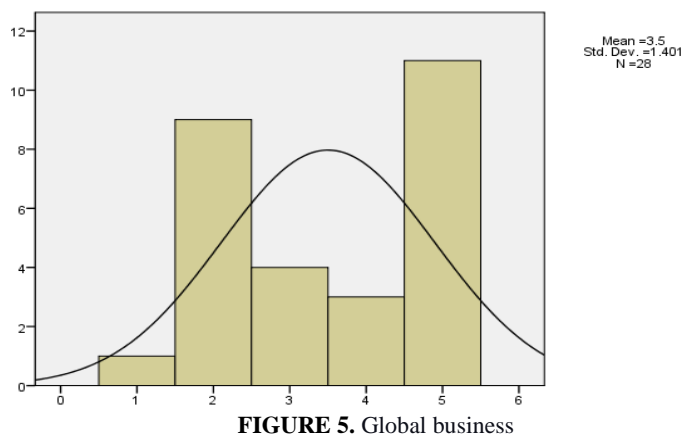

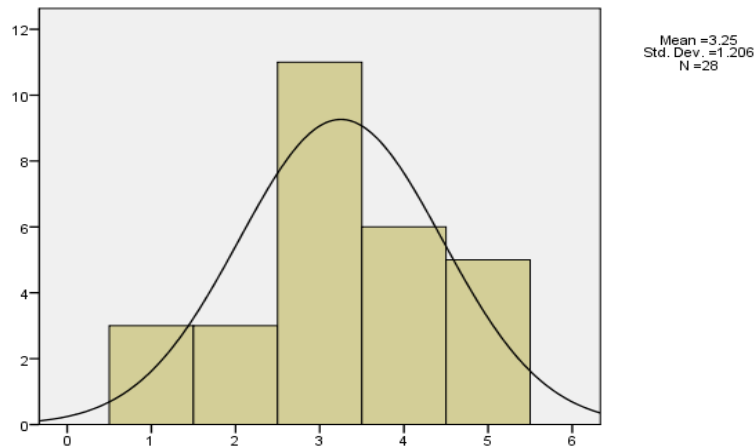


FIGURE 6. E-commerce

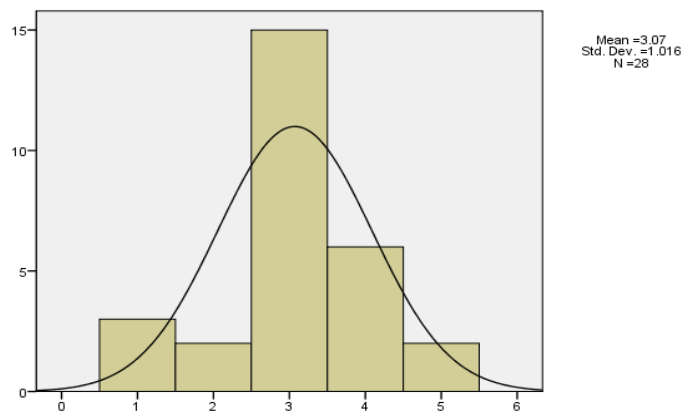


FIGURE 7. Retail and sales
