



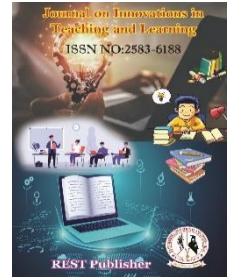

4. ANALYSIS AND DISCUSSION

Trends in Women's Literacy: India has shown significant progress in women's literacy. The female literacy rate increased from 80.35% in 2010 to 91.95% in 2021, representing steady annual improvements (World Bank, 2018). This growth reflects successful government and community interventions, although disparities persist.

Regional Disparities: Certain states, such as Bihar (60.5%), Rajasthan (57.6%), and Uttar Pradesh (63.4%), remain below the national average due to poverty, gender inequality, and inadequate infrastructure (National Commission for Women, 2020). By contrast, Kerala and Tamil Nadu demonstrate near-universal female literacy, indicating the effectiveness of social investments and community mobilization (Subramanian & Jeyakodi, 2018).

Causes of Low Literacy: The barriers to women's education in India are multifaceted: gender inequality (Kabeer, 2005); socioeconomic constraints (Kumar & Singh, 2017); early marriage (Bhatnagar, 2019); poor infrastructure (Ministry of Women and Child Development, 2018); safety concerns (Nayak, 2018); and lack of awareness (Subramanian & Jeyakodi, 2018).

Government Initiatives: The Indian government has implemented multiple schemes such as Sarva Shiksha Abhiyan (Planning Commission of India, 2014), National Programme for Education of Girls at Elementary Level (Ministry of Women and Child Development, 2018), Kasturba Gandhi Balika Vidyalyaya (National Commission for Women, 2020), and Beti Bachao, Beti Padhao (Government of India, 2018). **Role of NGOs and Civil Society:** Organizations such as Project Nanhi Kali, Pratham, and CARE India have been crucial in supplementing government efforts by mobilizing communities, providing resources, and addressing retention challenges (Bhatnagar, 2019).

Findings

1. India has achieved notable progress in women's literacy, but state-level disparities remain stark.
2. Socio-cultural barriers continue to undermine progress despite policy interventions.
3. Government schemes have increased enrollment, but dropout rates remain a major concern.
4. NGOs and civil society initiatives play a significant complementary role.
5. Achieving gender parity requires long-term socio-cultural transformation in addition to educational policies.

Suggestions

1. Strengthen school infrastructure and ensure safe learning environments.
2. Provide scholarships and financial incentives to support girls' education.
3. Implement community-based awareness campaigns to challenge patriarchal norms.
4. Expand digital and non-formal education opportunities for women.
5. Encourage public-private partnerships to increase outreach.
6. Integrate gender-sensitive training in teacher education programs.

Women's education in India has witnessed commendable growth in literacy rates over the past decade, but inequities remain across states and communities. While government programs such as SSA, NPEGEL, KGBV, and BBBP have made a difference, cultural attitudes and socio-economic constraints continue to pose significant challenges. Empowering women through education will lead to greater social justice, economic growth, and democratic participation.
